How often do I need to treat my plants and trees?

- Treat plants before browse begins, in spring or fall. Always treat new growth until the plant has reached full size or leaf-out.
- Plantskydd lasts up to 6 months over-winter on dormant plants and up to 3 months during the active growing season.

IMPORTANT: Apply on dry plants and allow solution to dry thoroughly for at least 24 hours before watering or rain.

CAUTION—For outdoor use only!

- Use within 90 days after breaking seal.
- Rinse sprayer after each use.
- If sprayer clogs, flush sprayer and tube with hot water.

KEEP OUT OF REACH OF CHILDREN AND PETS

- Do not ingest solution.
- Wash fruits and vegetables before eating.
- Wash hands / gloves after use.

DIRECTIONS: Shake container well before each use.

- **Avoid spraying concrete, brick or wood to prevent discoloration.**
- **Apply on dry plants**—Rainfast in 24 hours.
- Turn sprayer nozzle to **mist setting** and spray.
- After spraying, petals / leaves darken temporarily. Original color returns in a few days.
- **Always treat new growth.** Test sample plants to determine sensitivity.
- **Flush/rinse sprayer head and tube with water after each use.**
- **Deer / Elk / Moose**—spray mainly top of plant until wet, but not dripping.
- **Rabbits & Voles**—spray stem area, lower and underside of leaves.
- **Buckrub**—apply liberally all around tree trunk and limbs.
- **Over-winter**—prior to freeze-up, apply liberally to shrubs, hedges and trees.
- **Ornamentals**—spray mainly leaves of plants until wet—avoid blossoms.
- **Bulbs**—spray bulbs, allow to dry, and then plant.
- **Food Crops**—do not apply directly on edible parts of fruit, vegetables and other food crops 3-4 weeks prior to harvest.
- **Wash**—fruit and vegetables before eating.
