DIRECTIONS

- 1) Shake container well before using.
- 2) To pressurize bottle, pump top until you feel resistance (Approximately 10-20 times).
- 3) Press down on thumb trigger to release product.
- 4) Adjust stream by turning nozzle. If clogged, remove nozzle, separate and rinse under warm water.
- 5) Apply a fine mist to the plants that need protection, making sure all parts are covered, being careful not to overspray. When using on or near edible crops, apply the product when no above ground harvestable food commodities are present (usually pre bloom).
- 6) Allow twenty (20) minutes for this product to dry before watering of any kind.
- 7) This product can be applied in any climate or temperature as long as spray head and liquid are not frozen.
- 8) Repeat application as needed, usually every 30 days.
- 9) Release bottle pressure after each use by unscrewing top. Tighten top again before storing
