**Directions For Mix***Shake Well Before Using*

Mix 16oz (473 ml) of SNS 244C™ to 1 gallon (3.79 L) of water. Mix well until solution has a milky tint with some foam on top. Mixed solution may be stored or used immediately. For best results use warm (70 degree) Distilled or "Chlorine Free" Water.

**Directions For Use**

Test Spray for Phytotoxicity on a small area of the plant before use. Avoid spraying under direct sunlight or grow lights. Water infected plants well before spraying SNS 244C™. Spray directly onto fungus and infected areas until thoroughly covered. Spray as needed when fungus is seen, most effective when used on a 7-14 day schedule. Because it is made from natural ingredients you should shake the bottle before using and once in a while during use. Thoroughly wash all food areas and food materials contacted, with soap and water. Do not spray near heat or open flame.

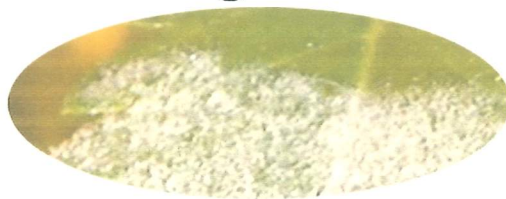
