Purpose:

Super Safe® Insecticide & Fungicide may suppress larvae, juvenile and adult populations of certain plant pests such as Spider Mites, Whiteflies, Aphids and Powdery Mildew.

Directions for Use on Indoor/Outdoor Plants:

1. Water the plant's soil.
2. Shake the bottle thoroughly.
3. Add 1-2 oz Super Safe® to quart spray bottle.
4. Fill bottle with water and shake to mix.
5. Spray the plant early or late in the day.

Application Directions:

Spray leaves, stems and buds.

For infestations, three (3) application days will be needed. Each application should be two to three (2-3) days apart.

For high populations of Spider Mites, spray 2-3 times each application day; allowing plant to dry between sprays.

Always wash produce prior to consumption.

Spray prior to beneficial insect release.
