DIRECTIONS FOR USE:

For outdoor use only. Ensure sprayer knob is in OFF position, shake bottle. Attach garden hose tightly to sprayer head. Turn hose on to full pressure, adjust knob to ON by turning clockwise. Spray the general area you are experiencing snake activity, then coat a 6" wide band around area. For food crops, apply protective band around periphery of garden. Do not apply directly to food crops intended for consumption. Before making widespread applications, it is recommended to test a small area of each type of plant to be treated to make sure that this product will not damage the plant. Do not water in the area after application. Reapply after heavy rains for best results.
