This Algaecide is economical, efficient and stable. In use dilution, this product is non-staining and non-corrosive to pool surfaces and equipment. This Algaecide is formulated to complement swimming pool water being treated with normal chlorine systems. It is especially effective against growth of algae and, being non-volatile, aids in maintaining pool water clarity and sparkle. The residual effectiveness of this algaecide tends to stabilize the total chemical treatment system.

This Algaecide is compatible with most chemicals normally used in swimming pool maintenance; however, in its concentrated form, this chemical must not come in contact with high concentrations of chlorine. DO NOT MIX ALGAECIDE AND CHLORINE TOGETHER before adding to the pool. These chemicals should be handled separately.

**FOR WINTERIZATION**

1. This Algaecide aids in the prevention of algae in swimming pools during the winter months, when the pool is out of service. This Algaecide is economical, efficient and stable.

2. Test water for proper balance of minerals, pH and presence of metals. Take corrective action if necessary.

3. Superchlorinate the pool using a recommended winter shock treatment according to label directions. Apply when pool is out of service and allow pump to recirculate a minimum of one hour, preferably several hours or overnight.

4. Apply this algaecide directly to the pool water, pouring along the edges of the pool. Use one quart per 20,000 gallons of water and allow to circulate 2-4 hours.

5. Clean pool water line and filter. In areas with severe freezing, drain pool equipment and plumbing lines or use an antifreeze recommended for swimming pool plumbing and equipment. Pools without covers or mesh covers, may need a second treatment in mid-winter or just prior to freezing.

**Rectangular Pools-** Length times width times average depth (in feet) times 7.5 equals gallons. **Round and Oval Pools-** Average diameter times average diameter times average depth (in feet) times 5.9 equals gallons.
