This product is a Trimec[®] herbicide containing fertilizer, 2,4-D, mecoprop-p, and dicamba. This granular weed and feed provides plant nutrients and controls a broad spectrum of broadleaf weeds in turfgrass. Supplemental nitrogen, phosphorus, and potash should be applied according to soil tests or State Extension Service recommendations.

This product is intended to be applied by noncommercial users, lawn care operators, and landscape personnel. Cool season grasses established in institutional, ornamental, and residential sites may be treated.

Institutional sites are defined as turf areas around properties or facilities providing a service to public or private organizations; for example areas around hospitals, nursing homes, schools, museums, libraries, sport facilities (including golf courses), and office buildings may be treated.

HOW MUCH TO APPLY:

Apply 140.5 to 158.4 lbs. of this product per acre of established turfgrass. Or the equivalent application rate is 3.23 to 3.64 lbs. of product per 1,000 square feet (sq. ft.) of turfgrass.

The maximum broadcast application rate is 3.64 pounds of product per 1,000 sq. ft. per application. The maximum number of broadcast applications is limited to 2 per year with a minimum of 30 days between applications. The maximum seasonal rate is 7.28 pounds of product per 1,000 sq. ft.

A sequential or follow-up application may be required for dense infestations of perennial and biennial weeds. Also, adverse environmental conditions prior or after application may reduce the effectiveness. - Spring and fall applications are recommended for the best control. However, this product can be applied any time broadleaf weeds are present and actively growing.
- 2. Mow the turfgrass 2 to 3 days before application.
