## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. **For outdoor use only.** DO NOT apply directly to residential lawns and turf in residential settings (e.g., homes, parks, schools, athletic fields or any other area frequented by the general public).

All outdoor spray applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

1. Application to pervious surfaces such as soil and other vegetation; 2. Applications to underside of eaves, soffits, doors or windows permanently protected from rainfall by a covering, overhang, awning or structure; 3. Applications around potential exterior pest entry points into man-made structures such as doorways and windows, when limited to a band not to exceed 1 inch; 4. Applications to vertical surfaces directly above pervious surfaces, such as soil, mulch or vegetation, only if the pervious surface does not drain into ditches, storm drains, gutters or surface waters.

Spot treatments must not exceed 2 sq ft in size (for example, 2 ft by 1 ft or 4 ft by 0.5 ft).

Do not spray the product into fish pools, ponds, streams or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies or aquatic habitat can occur. • Do not allow the product to enter any drain during or after application. • Do not apply directly to impervious horizontal surfaces, such as sidewalks, driveways and patios except as a spot or crack-and-crevice treatment. • Do not apply or irrigate to the point of runoff. • Do not make applications during rain. • Treat surfaces to ensure thorough coverage but avoid runoff. • To treat insects harbored in voids and cracks and crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants. • Do not apply when the wind speed is greater than 15 mph.

## WASPS, HORNETS & YELLOW JACKETS

1. Apply at sunset when insects are least active.
2. Stand a safe distance from the nest. Don't stand directly underneath.
3. Shake can well before each use. Aim spray away from person. Push button to spray.
4. Spray the nest until soaked. This product's powerful spray will also kill insects that return to the nest over the next few days.
5. Wait at least 24 hours before removing the nest.

Use of this product on evergreen and holly is not recommended, as damage may result.

\*This product is non-staining to most home siding depending on age and cleanliness. Before using in areas where the spray may contact home siding, test in an inconspicuous area and recheck in a few hours.

## USE TIPS

- If it's windy, stand with the wind at your back to avoid spray drift.
- Do not use this product in or on electrical equipment due to possibility of shock hazard.

## OTHER PESTS

**Tent Caterpillars:** Apply in the late afternoon or evening when caterpillars have returned to their tents. Soak tents on all sides. **Scorpions:** Stand at a safe distance and use the power of the jet spray to reach and cover the scorpion. **Ants:** Spray trails, nest and point of entry. Spray on ants where possible.

## STORAGE AND DISPOSAL

**Storage:** Store in cool, dry area away from heat or open flame.

**Disposal:** Do Not Puncture or Incinerate! If empty: Place in trash or offer for recycling if available. If partly filled: Do not pour or dispose down the drain or sewer. Call your local solid waste agency for disposal instructions.
