HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use 1.00 fluid oz. (2 tablespoons) of this product per 100 lbs. of fabric dry weight. Use a maximum of 60 gallons (500 lbs.) of water per 100 lbs. of fabric dry weight.

To soften laundered fabrics and obtain residual bacteriostatic activity against gram negative and / or gram positive odor-causing bacteria, dilute the appropriate amount of this product in one to two gallons of water and then add to the wash-wheel at the beginning of the final rinse cycle.

Repeat the treatment of fabric with this product after each washing.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **Pesticide Storage:** Open dumping is prohibited. Store in original container in areas inaccessible to children.

PESTICIDE DISPOSAL:

Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal Law. CONTAINER DISPOSAL:

Nonrefillable container. Do not reuse or refill this container. Clean container promptly after emptying.

Plastic and Metal Containers: Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15 – 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 – 20 minutes.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

Call a poison control center or doctor for treatment advice. Have the product container or label with you when calling a Poison Control Center or doctor or going for treatment.
