For difficult odors or heavy fabrics, repeat application. **To Kill odor-causing bacteria on soft surfaces:** Let air dry. For difficult odors or heavy fabrics, repeat application. Reapply as necessary.

For Soft Surface Spot Application: Test in an inconspicuous area prior to use.
