DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling. SHAKE BEFORE USING. Do not apply directly to food or to food serving or food preparation surfaces. Do not apply to pets or to your skin or clothing. Do not allow children or pets to contact treated surfaces until spray has dried. Do not spray indoors. For flying insects: Flies, mosquitoes. non-biting gnats, small flying moths, wasps, and multi-colored asian lady beetles. Hold can on a slight downward angle. Point nozzle away from face, other people and animals. From 4 to 6 feet away, spray articles and vegetation in the area including plant leaves and foliage, furniture (except seating and table top surfaces), outdoor screening, deck railings, campers, and other surfaces that pests may contact or rest upon. Allow spray to drift over area and settle. For best results, spray when air is calm. IF BREEZY, spray with the wind, IF NOT BREEZY, spray out from center of area being treated. Give special attention to breeding areas such as garbage cans and compost piles. DO NOT SPRAY DIRECTLY ON SKIN.

STORAGE AND DISPOSAL STORAGE: Store in a cool, dry place away from heat, sparks and open flame. DISPOSAL: Do not Puncture or Incinerate! If empty: This container may be recycled in the few but growing number of communities where aerosol can recycling is available. Before offering for recycling, empty the container by using the product according to the label. If recycling is not available, place in trash.
