3. WHERE TO USE:

Liquid Weed & Feed 20-0-0 Ready To Spray may be used on bentgrass, bermudagrass, Kentucky bluegrass, fescues, perennial ryegrass, and St. Augustinegrass lawns, vacant lots, playgrounds where broadleaf weeds are present. Liquid Weed & Feed 20-0-0 Ready To Spray controls listed broadleaf weeds, including sensitive weeds such as chickweed, clover, dandelion, knotweed and plantain.

4 WHEN TO USE:

Spray during the growing season when weeds are actively growing.

On new lawns, wait until the grass has reached a height of 2 inches before making an overall spray treatment. Wait three (3) weeks after application before sowing seed or planting stolons. Poor weed control may result if spray is applied during drought or just before rain. For best results, mow 1 to 2 days before treating. Do not water lawn within 24 hours after treatment

5 HOW TO USE:

Shake Well Before Using.

5.1 For Operation of Hose-End Sprayer:

Make sure knob control lever is in the "OFF" position. Shake well and attach to hose. Turn water on at faucet, aim nozzle toward lawn and turn knob control lever to "ON"

to begin spraying. When finished, turn control lever to "OFF" position. Turn faucet to "OFF" position. Discard residual water pressure by turning "ON" and "OFF" again.

5.2 For Bermudagrass, Kentucky Bluegrass, Fescues, and Perennial Ryegrass:Apply 13 fluid ounces (26 tablespoons) of product per 1,000 square feet of turfgrass.

Apply 8 fluid ounces (16 tablespoons) of product per 1,000 square feet of turfgrass. This product at this rate provides 0.12 pounds of nitrogen per 1,000 square feet per application.

5.4 Limitations on broadcast applications to turfgrass:

The maximum application rate is 13 fl. oz. of product per 1,000 sq. ft. per application. The Maximum number of broadcast applications is limited to 2 per year with a minimum of 30 days between applications. The maximum seasonal rate is 26 fl. oz. of product per 1,000 sq. ft. excluding spot treatments.

5.5 Limitations on spot treatments to residential turfgrass:
