DIRECTIONS FOR USE: SHAKE WELL BEFORE EACH USE. This product is ready to use from the bottle. Thorough coverage of the insect is required for maximum kill. Repeat application every few days if needed. *Apply early in the morning or late in the afternoon to avoid leaf burn.* May be used on edible crops up to the day of harvest.
