OUTDOORS: To prevent your pet, or stray animals, from soiling flower beds, areas of lawn, trees, shrubbery or evergreen: Spray the edges of flower beds, trunks of trees, the bases of shrubbery and evergreens, patches of lawn, etc., lightly every day, or every other day with this product. Stray animals are frequently attracted to areas where urine or feces have been deposited. First, remove any droppings, then spray the spot with this masking odor. Re-apply as often as necessary until undesirable habits of your pet or stray animals are changed. Garbage and Garbage Cans: Treat bags of garbage and garbage cans on all surfaces until wet. Allow drying before handling. Re-apply as necessary. Note: This product is not likely to break the established urination patterns of dogs unless used as a training aid.
