TREATMENT PRECAUTIONS - Read this before using: Apply this product in areas where it will not be disturbed. Airborne particles may cause respiratory irritation. Do not apply to drapes, clothing, or fabric. Not recommended for use on animal hair, wool carpets, or other delicate materials, consult with manufacturer before use. In the event of accidental treatment or spill, dilute with water and wipe off surface with a damp cloth, or vacuum up dry product with use of a HEPA filter vacuum.

DIRECTIONS FOR USE: Apply according to the label in attics, sub-area and other crawlspaces, wall voids, around electrical boxes, inside soffits and other construction voids, and anywhere insects are found, to help provide control of ants, centipedes, cockroaches, crickets, box elder beetles, earwigs, firebrats, silverfish, fleas, carpet beetles, millipedes, sowbugs, pillbugs, scorpions, spiders, wasps, bees, yellow jackets and other stinging insects, bed bugs and other nuisance pests. Retreat infestations as needed.

MIXTURE: READY TO USE PESTICIDE. Recommended for undiluted/direct use in power dusters, hand dusters, sprinkling, or liquid sprayers:

POWER DUSTERS: Apply 4 (four) cups per 1,000 (one thousand) square feet of sub-area or attic crawlspace.

HAND ("BULB") DUSTERS: Apply 2-5 (two to five) ounces on the wires/area behind electrical boxes.

SPRINKLING: Apply light sprinkling to infested areas or where insects crawl including, but not limited to, carpets, base of plants, structure, etc.

LIQUID SPRAYERS: Mix 1/4 (one-quarter) pound per gallon of liquid; apply liberally where insects crawl; including, but not limited to, walls, eaves, foundation, wall voids, and cracks & crevices. Note: Use precaution when spraying on walls and eaves as product may leave a residual discoloration (grayish) affect. First spray in test area and allow to dry before spraying entire surface.

Above are recommended amounts for application; however, product may be applied more abundantly than recommended amounts.

Statement of Practical Treatment: **If in eyes:** flush with plenty of water. **Skin:** Wash with soap and water.
