APPLY Aplique

Apply to dry lawn, then lightly water to activate.

Follow when and where to use directions below.

To keep lawn products from reaching storm drains, sweep or blow any stray particles off hard surfaces and back onto lawn.

WHEN TO APPLY

- Apply on a calm day.

WHERE TO APPLY

- Apply to newly seeded, overseeded, or newly planted Kentucky bluegrass, tall fescue, perennial ryegrass, centipede grass, as well as fine, spreading and creeping red fescues.

HOW TO APPLY

- Follow spreader instructions.
- Avoid application to adjacent flower beds when using a broadcast/rotary spreader.

WHAT TO EXPECT

- New weeds will sprout white or turn white and quickly die.
- This product will not kill existing weeds.
- This product may cause temporary whitening of grass foliage. Symptoms typically appear 5 to 7 days after application and may last up to 14 days.
- Discoloration is most common on ryegrass.

OTHER THINGS YOU SHOULD KNOW:

- For home lawns only.
- This product applies 0.15 pounds of Mesotrione per acre per application.
- The maximum application rate of Mesotrione per treatment site per year is 0.45 lbs.
- This package applies 4.3 pounds of product per 1,000 sq. ft.

USE PRECAUTIONS

- Do not apply this product in a way that will contact any person, or pet either directly or through drift. Keep people and pets out of the area during application.
- Do not enter or allow people or pets to enter the treated areas (except those involved in the watering) until the watering is complete and the surface is dry.
- Do not use this product on flowers, shrubs, trees, fruit or vegetable plants. Cana, day lilies and irises are especially susceptible to injury.

CUÁNDO APLICAR

- Aplíquelo un día que no haya brisa.

DÓNDE APLICAR

HOW TO CARE FOR YOUR NEW GRASS

Watering

After you've planted your new grass, continue to water at least twice a day (or more frequently if the weather is hot), until it has been mowed 1-2 times. Once your new grass is established, you can go back to a normal watering routine.

Feeding

Feeding is important for all lawns, but it's especially important for new grass plants. To keep your new grass growing and maintain a thick, green appearance, provide a follow-up feeding in 2-4 weeks with Scotts® Turf Builder® Starter® Food for New Grass. If you live in an area where Phosphorous applications are limited, feed with Scotts® Turf Builder® Lawn Food instead. Once your new grass is established, continue with regular feedings every 6-8 weeks.

Mowing

If you've seeded bare spots or a whole lawn, wait to mow the area until the new grass is at least 3 inches tall. If you've seeded over your existing lawn, you can mow as needed, but try to cut back the frequency to limit traffic on the new seedlings.

Treating Weeds

Wait until you've mowed your new grass at least 4 times before treating the new grass with a crabgrass preventer or other weed control product. Always read the product label for specific information related to the weed control product you are using. This product prevents weeds for 6 weeks.

Treating Bugs

Most bug control products can be used any time on newly planted grass. Always read the product label for specific information related to the pest control product you are using.

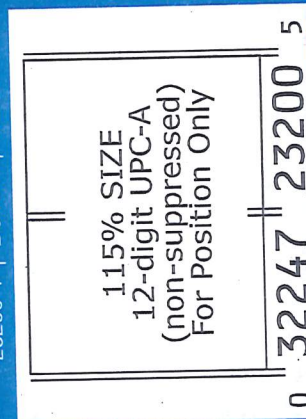
