FIRST AID

USE RESTRICTIONS

For outdoor use only. Do not allow persons or pets to enter the treated area until dusts have settled. Do not apply this product in a way that will contact any person or pet, either directly or through drift. Keep people and pets out of the treated area during application. Do not apply directly to foliage of shrubs or to ornamental, soft-bodied plants. Do not apply to food or feed crops.

User Safety Recommendations: Users should wash hands before eating, drinking, using tobacco or using the toilet. Users should remove clothing immediately if pesticide gets inside or on clothing. PRE-TREATMENT DIRECTIONS: Stray animals are frequently attracted to areas where pets have soiled with feces or urine. To discourage repeat visits, remove any droppings and clean with water.

APPLICATION DIRECTIONS: Lightly sprinkle granules directly from the container or use a spreader at the rate of 1 lb. per 250 sq. ft. Apply as a border to the item to be protected.

RE-TREATMENT DIRECTIONS: Repeat daily, or as necessary, until undesirable habit is broken.

STORAGE AND DISPOSAL

PESTICIDE STORAGE: Store only in the original container in a cool, dry place inaccessible to children and pets.
