#### DIRECTIONS:

- **Shake container well before using.** Product is ready to use and does not need to be mixed or diluted.
- Adjust sprayer to desired spray pattern.
- Lightly spray plant leaves, stems, flowers and branches that need protection, making sure plants are covered. Do not overspray. When using on edible crops, apply the product when no above-ground harvestable food commodities are present, including blossoms.
- Allow 20 minutes for this product to dry before watering of any kind.
- Repeat application as needed, usually every 30 days or at the first sight of new damage.

This product can be applied in any climate or temperature as long as spray head and liquid are not frozen. If product freezes, return to room temperature and use according to directions.
