

FIRST AID

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse. Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals.

ENVIRONMENTAL HAZARDS: This pesticide is extremely toxic to aquatic organisms, including fish and aquatic invertebrates. Do not contaminate water when disposing of aerosol unit, washwater or rinsate. See Directions for Use for additional precautions and requirements. Do not apply directly to water. **PHYSICAL OR CHEMICAL HAZARDS:** Contents under pressure. DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USE. GENERAL PRECAUTIONS AND RESTRICTIONS: For Indoor Residential Use Only. Do not use as a space spray. Do not apply this product in a way that will contact adults, children or pets, either directly or through drift.

Do not apply when food is present. Exposed food should be covered or removed. All food preparation surfaces and utensils should be covered during treatment or thoroughly washed before use. Do not use water based sprays in conduits, motor housing, junction boxes, switch boxes, or other electrical equipment.

During any indoor surface application, do not allow dripping or runoff to occur. During any application to ceilings of a structure, cover surface below with plastic shielding or other material.

Do not apply this product in any room being used as a living, eating, or recovery area by the elderly or the infirm when they are in the room. Do not exceed maximum application rate of 16 seconds of spraying per each sq. ft. of surface. Remove pets and birds and cover fish aquariums before spraying. Do not apply to humans, pets, plants, or contact food, dishes or utensils. Do not allow children or pets to contact treated surfaces until spray has dried.

For use in areas such as: Apartments, Atriums, Artios, Basements, Bathrooms, Bedrooms, Bookcases, Carpets, Chests, Closed Porches, Closets, Clothes Storage, Dens, Dog Houses, Draperies, Furniture, Garages, Garbage Cans, Gazebos, Homes, Household, Kitchens, Lardis, Living Rooms, Pantries, Pet Bedding, Pet Sleeping Areas, Pet Carriers, Play Houses, Play Rooms, Porches, Rugs, Solariums, Storage Areas, Sun Porches, Sun Rooms, Utility Rooms and Verandas.

Kills the following insects on contact: Ants, Argentine Ants, Asian Lady Bird Beetles, Brown Dog Ticks, Black Carpenter Ants, Carpet Beetle, Cockroaches, Crickets, Fleas, Foraging Ants, German Cockroaches, Palmetto Bugs, Pharaoh Ants, Red Harvester Ants, Scorpions, Silverfish, Sow bugs, Water bugs.

For residual control of German cockroaches spray non-porous surfaces until coated along baseboards, under sinks, refrigerator, stove, dishwasher, or other places where cockroaches may hide.

CRACK AND CREVICE SPRAY: Apply spray in small amounts directly into cracks and crevices. Pay special attention to areas such as behind baseboards, connecting areas around drains and pipes, behind and beneath sinks, stoves, and plumbing, and other visible cracks and crevices. Spray these areas thoroughly, making certain that spray penetrates well.

CONTACT APPLICATION: Spray at the rate of one linear foot per second. Contact as many insects as possible with this spray, in addition to thoroughly spraying of all parts of the room suspected of harboring these pests. Pay special attention to hiding places such as beneath sinks, behind and beneath stoves and refrigerators, around garbage cans and cabinets, along the outside of baseboards, floor sills, frames and floors, around and on drains, pipes and plumbing, behind bookcases, storage, and other utility installation areas, contacting insects with spray when possible.

Carpet Beetles: Directly spray as many insects as possible. Where possible, bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture, on floors and walls, around windowsills and baseboards, and wherever these insects are seen or suspected. Backing of carpets and rugs should be allowed to dry before re-laying on floor. **Foraging Ants, Southern Fire Ants and Foraging Carpenter Ants:** To kill foraging ants, including Southern Fire Ants and Black Carpenter Ants spray insects directly and on ant trails.

FOR SPOT TREATMENT: To Kill Brown Dog Ticks and Fleas: Thoroughly spray, as a spot treatment, infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests may be present. Do not exceed 16 seconds of spraying per each square foot. Pet's old bedding should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Pets should be treated with a registered flea and tick control product prior to reentering treated areas. Also, treat your yard with a product registered for yard application.

To Kill Spiders, Carpet Beetles, Cockroaches, Palmetto Bugs, Asian Lady Bird Beetles, Crickets, Scorpions, Silverfish and Sow bugs: Spray areas where these insects are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets; and around garbage cans, plumbing, and other utility installations. Pests driven out of hiding places should be sprayed directly.

STORAGE AND DISPOSAL: **PESTICIDE STORAGE:** Store in a cool, dry area. Keep container closed. Always store pesticides in the original container. Store away from food and pet food. **PESTICIDE DISPOSAL AND CONTAINER HANDLING:** Do Not Puncture or Incinerate. Nonrefillable container. Do not reuse or refill this container.
