USE RESTRICTIONS:

This bait station may be used in areas accessible to children and pets, consistent with all use restrictions and other requirements indicated on this label. Do not apply further than 50 feet from a home or building.

For control only of Norway rats, roof rats, and house mice. This bait station can only be refilled with the block baits sold with this station. TOMCAT RAT KILLER II must be used in and around buildings consistent with all use restrictions and other requirements indicated on this label. 
