

STORAGE/DISPOSAL

Do not use on wilted or stressed plants.

To Apply: Spray over and under all leaves directly on the problem and surrounding vegetation. It is best to spray in the evening or when plants are not under bright light, For Spider Mites: Apply 3 times, 3 days apart.
