DIRECTIONS

SHAKE WELL BEFORE EACH USE

Transfer to a spray bottle. **Test on a few leaves before use.** Wait 24 hours. If leaf burn occurs, dilute with 1 part water to 3–4 parts ZT. Different varieties of plants have varying responses to pesticide strength.

Do not use on wilted or stressed plants.

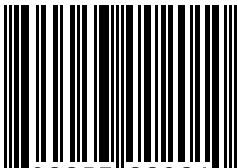
To Apply: Spray over and under all leaves directly on the problem and surrounding vegetation. It is best to spray in the evening or when plants are not under bright light. **For Spider Mites:** Apply 3 times, 3 days apart.

STORAGE/DISPOSAL

Store and dispose of in a cool, dark place.
