**TO DEODORIZE:** Dilute ECO-SECT from 1:30 up to 1:1 with water (4.3 to 128 fl oz of ECO-SECT per gallon of water), as needed to mask foul odors.

#### SPRAY APPLICATIONS

**TO KILL FLIES:** Dilute ECO-SECT up to 1:15 with water (No less than 2 fl oz of ECO-SECT per 32 fl oz of water). Shake or mix until uniform. Spray directly onto flies using a coarse spray. Contact as many flies as possible.

**TO DEODORIZE:** Dilute ECO-SECT from 1:30 up to 1:10 with water (1.1 to 3.2 fl oz of ECO-SECT per 32 fl oz of water). Shake or mix until uniform. Spray directly onto the source of foul odors and into areas with foul odors.

**TO CLEAN/DEGREASE:** Shake or mix until uniform. Spray directly onto surface. For heavy soils allow product to work for 15 minutes. Rinse with water. For use in California, this product must be diluted 1:1 with water.
