### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**USE RESTRICTIONS:** For residential use only on home lawns, flower and vegetables gardens, fruit, nut and ornamental trees, and wooden structures and fences around the home.

**Deer, Rabbit and Tree Squirrels:** This product repels deer, rabbits and tree squirrels from the following fruits and vegetables: citrus fruits, root and tuber vegetables, bulb vegetables, leafy vegetables, brassica (cole) leafy vegetables, legume vegetables, fruiting vegetables and cucurbit vegetables. It also can be used on all indoor and outdoor ornamental plants and wooden structures and fences.

**ALL USES:** Apply this product using attached sprayer. Do not apply this product through any type of irrigation system.

**Application and Retreatment Directions for Plants:** Apply this product as a foliar spray to the leaves, stems, fruits, and flowers of the plant until wet. Do not trench roots in soil or media. Do not apply when rain is expected within 24 hours.

Initially apply until foliage is wet. Repeat application in 3-7 days, for 2-3 weeks, until control is established. ONCE CONTROL IS ESTABLISHED apply every 2-4 weeks, as necessary to maintain control.

### HOW TO USE

#### TWIST & SHOOT™ READY-TO-SPRAY INSTRUCTIONS

- 1) Make sure control knob is in "OFF" position, then connect to garden hose.
- 2) Turn water on at faucet. When spraying low growing plants and small shrubs, twist the control knob right, to the "FAN" position. When spraying taller trees, shrubs and other plants, twist the control knob left to the "STREAM" position for extended reach and more uniform coverage. The product mixes automatically with the water as you spray.
- 3) To stop spraying, turn the control knob lever to the "OFF" position. Turn off water at the faucet and disconnect sprayer from garden hose.

#### STORAGE AND DISPOSAL

Store and transport in an upright position. Store in a cool dry area inaccessible to children or pets. **Dispose!** If empty: Nonrefillable container. Do not reuse or refill this container. Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.

#### FIRST AID

#### If In Eyes:

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**CAUTION:** Causes eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling.

#### ENVIRONMENTAL HAZARDS

This product may be toxic to aquatic organisms. To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain does not blow or wash pesticide off the treatment area.
