Allow the pet to shake its head. Wipe excess lotion from the ear. Repeat every two days until the condition has improved, or as directed by a veterinarian. Do not use longer than 14 days without consulting your veterinarian.

**AS A PREVENTATIVE TREATMENT:** Apply lotion every 15 days to prevent ear mite infestation. Sensitivities may occur after using any pesticide product for pets. If any signs of sensitivity occur consult a veterinarian immediately.

**STORAGE AND DISPOSAL**

**STORAGE:** Store in a cool, dry area and avoid direct sun and excess heat.
