

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read entire label and use strictly in accordance with precautionary statements and directions. Even pools equipped with salt chlorine generators (saltwater pools) can get algae. **Salt Solutions by Ultima® Algaecide** is a triple-action formula that quickly and effectively removes all types of pool algae. Use **Salt Solutions by Ultima® Algaecide** as part of your weekly maintenance program to keep your water clear and free of visible algae. Always add **Salt Solutions by Ultima® Algaecide** with the pump and filter running to ensure complete mixing and good circulation.

**SHAKE WELL BEFORE USING**

- INITIAL TREATMENT FOR PREVENTION OF ALGAE GROWTH IN CLEAR POOL WATER:** Use 8 to 12 fluid ounces of this product for every 10,000 gallons of water.
- INITIAL TREATMENT FOR POOLS WITH VISIBLE ESTABLISHED ALGAE:** Use 16 to 24 fluid ounces of this product for every 10,000 gallons of water. Remove dead algae by vacuuming.
- BLACK ALGAE CONTROL:** Apply 16 fluid ounces for every 10,000 gallons of water when algae first appears. Brush spots daily to remove dead algae. Vacuum out settled algae.
- TO MAINTAIN POOLS FREE OF VISIBLE ALGAE GROWTH:** Use 4 to 8 fluid ounces of this product per 10,000 gallons of water weekly.

**METHOD OF APPLICATION:**

Never mix concentrated product with other concentrated pool chemicals such as concentrated dry or liquid chlorine. When properly diluted in the pool, **Salt Solutions by Ultima® Algaecide** is compatible with those chemicals normally used to treat pools.

- SHAKE WELL** before measuring out required amount of **Salt Solutions by Ultima® Algaecide**.
  - Apply directly to the pool water with the circulation system turned on.
  - Allow at least one hour for product to be distributed before turning off the pump.
  - Repeat treatment until control is evident.
- ELIMINATION OF VISIBLE, ESTABLISHED ALGAE:** Use 24 fluid ounces of **Salt Solutions by Ultima® Algaecide** for every 10,000 gallons of water. Brush sides and bottom of pool daily. When pool has cleared, vacuum out settled algae.

**FIRST AID**
