### FIRST AID

**General Product Information**

Messina Wildlife's Mole Stopper Smoke is a plastic smoke generator containing Castor oil. When the generator is lit and put down the mole's tunnel, the Castor oil coats the tunnel, forming a physical barrier over it's surface and tainting the mole's food source.

**How to Select Treatment Areas**

The presence of moles may be indicated by a network of surface ridges in the turf or by a series of conical mounds of earth pushed up from deep burrows, or by damage to flower bulbs. Locate mole tunnel in the area most affected

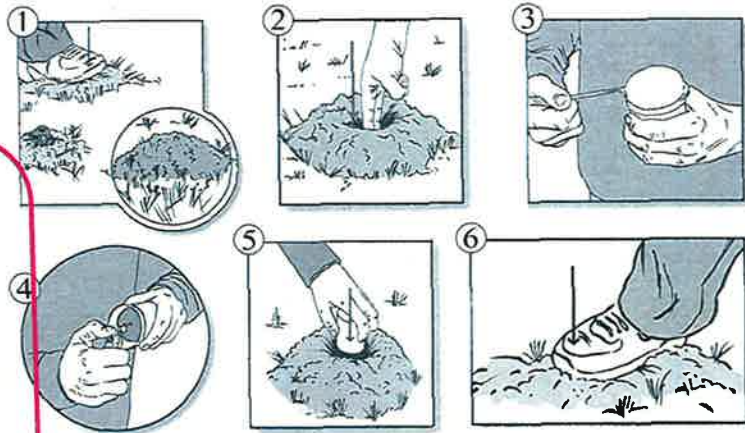
by molehills. The tunnel can be found immediately beneath a molehill. Prior to treatment, determine which burrows are active according to one of the following two methods. Either press down a small section of the tunnel or remove a one inch section of the tunnels roof. Mark these sections and recheck in 24 hours. The burrow is considered active if the flattened runway has been raised up or if the roof has been repaired. Only treat active burrows. Ensure all other tunnel holes are well covered with earth to prevent smoke from leaking out after activation.

**Application Instructions**

Use one Messina Wildlife's Mole Stopper Smoke generator to treat three molehills or up to 130 feet of mole tunnels.







### How to Activate and Place Smoke Generator

Remove the lid of one generator and light fuse using a match or lighter. Once lit, immediately push the generator down the tunnel as far as possible with the lit end pointing into the tunnel away from your hand. If the generator is not immediately placed into the tunnel, the outside of the container will become hot to the touch. Smoke will begin to diffuse approximately ten seconds after lighting the fuse.

Cover the hole by gently tamping down the earth. The generator will produce smoke for approximately 40 seconds. Check the surrounding area for any sign of smoke leaking out of tunnels. After 24 hours, remove the empty generator from the tunnel. After a few days, check to see if the burrows are still active according to one of the two methods described above. If so, repeat treatment.
