

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read Entire Label.

USE RESTRICTIONS

- For spot, crack, and crevice application only.
- Do not apply more than 112 lbs. (1782 ounces or 89 bottles) of this product (0.56 lbs. ai PBO) per 1000 square feet.
- Not for broadcast use on indoor surfaces.
- Do not apply this product in a way that will contact adults, children, or pets either directly or through drift.
- Do not allow adults, children, or pets to enter the treated area until sprays have dried.
- Do not apply when food is present. Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use.
- Remove pets, birds and cover any water inhabited by fish (such as aquariums and ornamental fish ponds) before spray application. Turn off aquarium filtering systems before spraying and wait approximately 15 minutes after application before turning the filter back on.
- Do not use in commercial food/food handling establishments, restaurants or other sites where food/food is commercially prepared or processed. Not for use in federally inspected meat and poultry plants.
- Do not apply to pets or contaminate food, foodstuffs, dishes or utensils.
- Do not make application during rain.
- Do not apply directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.
- Do not wet articles to point of runoff or drip.

- Close milk buds to prevent contamination from spray and from dead or falling insects. Remove or cover milking utensils before application. Wash teats of animals before milking.

Other than application to building foundations, all outdoor applications to impervious surfaces such as sidewalks, driveways, patios, porches and structural surfaces (such as windows, doors and eaves) must be limited to spot or crack and crevice treatments only, except for the following permitted uses: Treatment to soil or vegetation around structures; Applications to lawns, turf, and other vegetation; Applications to building foundations, up to a maximum height of 3 feet.

For best results, spray in early morning or late evening when insect activity is minimal. Stand a safe distance from nest and not directly underneath. Remove protective cap. Hold can upright and point spray opening toward nest with wind at your back. Spray until nest is thoroughly saturated to kill the entire nest population. Residual action will kill Wasps and Hornets returning to the nest. Wait at least 24 hours before removing the nest.

To kill Wasps, Hornets, Yellow Jackets and Bees under eaves, screens, window frames, doors, patios, cracks, holes or crevices whenever insects are noticed, spray for about 1 - 2 seconds or until surfaces are moist. To prevent entrance of insects into the house, spray around points where insects can enter house; outside plumbing, faucets, and cracks or crevices in foundation as well as along sills and ledges.

Do not spray vegetation directly to prevent damage to foliage. If spray accidentally contacts foliage, immediately wash with water. This product may discolor exterior surfaces of building, structures and painted surfaces and may cause staining (darkening) of asphalt surfaces and shingles. Test product in an inconspicuous area before applying.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **Pesticide Storage:** Store in a cool, dry area away from children and pets and away from heat, sparks and open flame. Do not transport or store below 32°F.
