

## DIRECTIONS FOR USE:

SHAKE WELL BEFORE USING. READ ENTIRE LABEL AND USE ACCORDINGLY. FOR USE OUTDOORS AND IN ATTICS.

WASP, HORNET, OR YELLOW JACKET TREATMENT: If possible, apply at sunrise or sunset when insects are least active in nest. Stand a safe distance from the nest. Hold container upright and aim nozzle away from yourself. Spray with wind at your back. Press button firmly to spray. Spray until the nest is soaked. Expose as many insects as possible. Repeat

NOTE: Avoid spraying directly on plants. Foliage exposed to spray should be hosed off. This product is non-staining to most home siding depending on age and condition, however, it may leave a temporary oil mark. While staining is unlikely, it is recommended to spray product on an inconspicuous area of surfaces that are intended to be treated. A test duration of 48 hours or more is recommended. This product is not recommended for use on vinyl siding, or window or door casements made of vinyl moulding.

DIELECTRIC INFORMATION: Electrically non-conducting up to 41,000 volts. PRECAUTIONARY STATEMENTS: This product is safe for use around children and pets when used as directed.
