DIRECTIONS FOR USE:

SHAKE WELL BEFORE EACH USE. AIM SPRAY NOZZLE AT RED DOT ON RIM. READ ENTIRE LABEL AND USE ACCORDINGLY.

FOR BEST RESULTS: Vacuum infested room thoroughly including mattress, foundation/box springs and upholstered furniture before using this product. Vacuum the carpet/rugs/flooring, especially where the carpet/flooring meets the wall near the head of the bed. Take vacuum cleaner bag to the outdoor trash immediately. To avoid exposure to airborne solution, it is recommended that this product is used in well ventilated areas.

FOR MATTRESS APPLICATIONS (Bed Bugs and Dust Mites): Remove all bedding and wash in hot water. Remove the mattress and box spring from bed. Hold can 6 inches from mattress and spray across all folds, tufts, seams and edging until damp. Also spray the seams and underside of the box spring. Allow mattress and box springs to dry completely before placing back on bed and bedding. Repeat as necessary. To avoid exposure to airborne solution, it is recommended that this product is used in well ventilated areas.

FOR CARPET/RUG APPLICATIONS (Bed Bugs, Dust Mites and Fleas): Hold can 2 feet from floor and spray carpet/rug using a smooth back and forth sweeping motion. Focus on areas where bed bugs, dust mites and fleas may hide or rest. Spray entire carpet in room. The critical areas are carpeting/rugs adjacent and under the bed. Spray until damp. Avoid over-wetting or saturating carpets/rugs. Allow carpet/rugs to dry completely and vacuum again. Repeat as necessary. To avoid exposure to airborne solution, it is recommended that this product is used in well ventilated areas.

NOTE: Effective bed bug and flea control typically requires thorough and multiple applications. Visit www.ecosmart.com for more information. This product contains plant oils which are inherently fragrant. For people and pets that are fragrance or plant oil sensitive, test a small application before using over a larger area. While staining is unlikely, as with most household products it is recommended to test for staining on an inconspicuous area of all surfaces to be sprayed before using. Wipe away excess product on furniture immediately after application. To prevent slipping on hard surfaces, wipe away excess product with a damp cloth.

PRECAUTIONARY STATEMENTS: This product is safe for use around children and pets when used as directed. Caution – We recommend good safety practices when using any insecticide, such as avoiding contact with eyes and skin and keeping out of the reach of children and pets.
