It is formulated for use by exterminators, grounds keepers, maintenance personal and professional pest control operators. Developed for residential, commercial and industrial facilities.

STOP BUGGING ME!™ Lawn & Garden Ready-To-Spray Outdoor Pest Control is effective for the control of grubs when applied on turf areas experiencing grub infestations that often result in damage to the sod. **DIRECTIONS FOR USE:** Shake well before using. Connect sprayer to garden hose. Turn on water. To begin spraying, point nozzle in the direction you want to spray. Bend small plastic tab on side of sprayer back and turn dial clockwise to ON position. Spray evenly over measured area. To stop spraying, bend small plastic tab back and turn dial counter clockwise to OFF position. Turn off water. Relieve water pressure by bending plastic tab back and turning dial to ON position until water slows to a drip. Then turn dial back to OFF position. Disconnect sprayer from garden hose. Allow product to dry after application, before entering treated area. Do not spray flowers or flowering plants while bees are present. For use against grubs, to insure that the active ingredients reach sub-soil depths in affected areas, apply a minimum of 2 gallons of water per 1,000 sq. ft. of surface area.

**APPLICATION RATES:** Repeat application every 30-60 days or as often as required.

**FOR OUTDOOR USE ONLY. Not for use in vegetable gardens.**

**FIRST AID**
