APPLICATION DIRECTIONS: Timing: Apply between the hours of 8 a.m. and 11 a.m. or late in the afternoon between 5 p.m. and 8 p.m. Avoid applying during the heat of the day, in windy conditions or when rain is expected within 24 hours. AREAS TO FOCE: Stop Bugging Mel Multi-Action Fogging Solution is for outdoor use only. Fogging should be aimed at flowerbeds, trees, and grassy areas. Fog may also be applied to standing water, puddles etc. Product is not for indoor use; however, product may be applied in unpopulated barns, stalls, etc. Product should not to be applied to animals or humans.

METHOD: Stop Bugging Me! Multi-Action Fogging Solution may be applied via hot or cold electric or propane operated insecticide fogging device. Do not dilute. Following directions on the hot or cold fogging device, hold container 14-20 inches from flowerbeds, trees, shrubs, grassy areas and other areas infested with pests. Spray with a slow sweeping motion moving backward away from spray. Do not spray towards adults, children or pets. Do not spray if food is present. Allow spray to dry completely before occupying the area. May cause stains and/or burn some susceptible plants. Always test a small, inconspicuous area before full application. STORAGE AND DISPOSAL: Do not contaminate water, food, or feed by storage and

STORAGE: Store in a cool dry area inaccessible to children or pets. Store and transport in an upright position. Keep from freezing. Store unused material, tightly closed, in original container and keep container closed when not in use. CONTAINER HANDLING: Nonrefillable container. Do not reuse or refill this container. If empty: Place in trash or offer for recycling if available. If partly filled: Call your local waste agency for disposal instructions.
