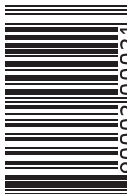

## **DIRECTIONS FOR USE:**

### **SHAKE WELL BEFORE EACH USE. READ ENTIRE LABEL AND USE ACCORDINGLY**

#### **BEFORE YOU USE**

- Ready-to-use. Do not dilute.
- Do not apply directly on dogs.
- For best results lawn should be mowed a day or two before spraying.
- Apply on a dry day and do not use if rain is expected within 24 hours.
- Delay watering for 48 hours after application.
- Reapply after a heavy rainfall, and/or every three weeks to four weeks or as necessary.
- If temperatures exceed 85° F, spray in early morning or early evening when it is cooler. Do not apply in mid-day sunlight as temporary leaf burn may occur.
- Avoid spraying young flowering plants.

#### **HOW TO USE Shake Well Before Each Use**

##### **SPRAYING DIRECTIONS:**

- Connect sprayer to hose. Make sure the dial indicator on the nozzle is in the "OFF" position behind the safety tab.
- Turn on water. Extend hose to the farthest area to be treated and work back towards the faucet to ensure complete coverage.
- To BEGIN spraying, hold container upright and point nozzle toward treatment site (do not aim toward the ground) Bend the small plastic safety tab back with your thumb and turn knob clockwise until it stops in the "ON" position. Water will automatically mix with the product.
- Spray as directed in the instructions for each use site below.
- To STOP spraying, bend the small plastic safety tabs back and turn dial counter-clockwise until the dial indicator is in the "OFF" position behind the safety tab.
- Turn water off. To relieve pressure before removing sprayer from the hose, bend the safety tab back and turn dial to "WATER" until the water stops spraying. Then turn back the "OFF" position.
- Disconnect sprayer from hose.

### **FOR APPLICATIONS ON LAWNS AND KENNELS FOR FLEA & TICK CONTROL**

#### **HOW TO USE Shake Well Before Each Use**

##### **HOW TO APPLY:**

- Use entire bottle (1 quart) of EcoSMART® Flea & Tick Control to treat up to 5,000 sq ft.
- Apply evenly using a sweeping motion over desired area.
- Be sure to cover entire area, especially where dog(s) normally frequent, including under/around shrubs, trees, porches, inside/around kennel, etc.
- Allow product to dry before allowing dog(s) to enter treated area.
- Repeat every 30 days (during flea and tick season) or as necessary.

**HOW TO APPLY:**

- Apply as a thorough foliar spray.
- Wet leaves and branches to the dripping point. Try to spray underside of leaves and penetrate dense foliage.
- Spray any standing water and under porches and decks.
- Delay watering for 48 hours after application.
- Repeat every 30 days (during mosquito season) or as necessary.

**PESTS CONTROLLED: Kill & Repels**

**Fleas, Ticks and Mosquitoes.**

**FOR TICK CONTROL:** Apply directly to lawn when the grass is less than 3 inches tall. Reapply every two weeks for maximum effect to break the life cycle.

**FOR MOSQUITO CONTROL:** Apply at dawn or dusk when mosquitoes tend to be the most active and accessible to spray. Repeat applications may be necessary for heavy infestations.

**PRECAUTIONARY STATEMENTS:** This product is safe for use around children and dogs when used as directed. Caution – We recommend good safety practices when using any pesticide, such as avoiding contact with eyes and skin and keeping out of the reach of children and dogs. If product gets in eyes, flush with water. If on skin, wash with soap and water. If irritation persists, contact a physician.

**STORAGE AND DISPOSAL:** Turn nozzle to “OFF” position behind the safety tab. Store in original container in a cool, dry area and avoid excess heat. Keep from freezing. Do not reuse container. Offer for recycling if available or discard in trash.
