**Dr. Earth® Vegetable Garden Insect Killer** controls aphids, whiteflies, mites, caterpillars, earwigs, sowbugs, beetles, scale, spiders, ants, leafhoppers, mealybugs, pillbugs, crickets and other insects. *Dr. Earth® goes to work immediately*; death generally occurs minutes to hours after application.

**DIRECTIONS FOR USE: SHAKE WELL BEFORE EACH USE.**  
**HOSE END SPRAYER:** Make sure the handle control lever is in the OFF position. The handle should be facing vertical and in the lock tab. Attach to the hose. Turn on faucet, aim the nozzle toward area to be sprayed – “bend tab back” – then TURN the handle ON by turning it clockwise to begin spraying the product. **When finished application:** “bend tab back” turn the handle counter-clockwise to the OFF position. Turn off faucet. “Bend tab back” to discharge residual water pressure by turning ON and OFF again. *Repeat application every few days if needed.*

**NOTE:** Make sure to spray branches and the underside of leaves until the plants are dripping. Please spray early in the morning or after 4:00 PM to avoid any leaf burning.

**PRECAUTIONARY STATEMENTS: CAUTION: KEEP OUT OF REACH OF CHILDREN.** Avoid contact with skin, eyes or clothing. Do not swallow. Wash thoroughly with soap and water after handling. Do not apply directly to water.
