STOP. READ ENTIRE LABEL BEFORE USE.

USE INFORMATION: SHAKE WELL BEFORE EACH USE. To ensure optimum performance hold can upright at all times while spraying. Failure to do so can result in loss of propellant. Do not spray up into air. Apply to surfaces only. Direct spray away from face. Hold can 12-18 inches from surface being sprayed. Press button down and spray as directed.

This product's long-lasting action keeps on killing **Carpenter Ants** for up to 30 days. More frequent applications may be necessary on concrete surfaces. Check these areas in 4 weeks and re-treat if insect activity continues. Residual activity kills insects when they return to treated areas. This formulation is non-staining on surfaces where water alone does not stain. However, when treating delicate fabrics or high value items, first test an inconspicuous area and allow to dry.

This product is intended to be used in and around residences and their immediate surroundings including: apartments, attics, automobiles, basements, bathrooms, boats, cabins, campers, carports, cat sleeping quarters, clothes storage, condominiums, decks, dens, driveways, garages, gazebos, homes, kitchens, lanais, living rooms, parlors, patios, pet sleeping areas, play rooms, porches, recreational vehicles, rooms, solariums, storage areas, sun rooms, utility rooms and verandahs. Do not use in commercial food/feed handling establishments, restaurants or other places where food/feed is commercially prepared, processed or stored.

INDOORS:

CARPENTER ANTS: For effective control, locate and treat nests and surrounding areas. Apply around doors and windows and other places where ants enter premises and where they crawl and hide. Spray into infested wood through existing openings. Apply as a spot and crack-and-crevice treatment to areas where these pests crawl and hide, especially in hidden areas around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stoves, the underside of shelves, drawers, bookcases, and similar areas. Cover all food handling surfaces and cover or remove all food and cooking utensils or wash thoroughly after treatment. Cover or remove exposed food. Repeat as necessary but not more than once per week.

CONTACT SPRAY: To kill carpenter ants, spray where insects congregate and individual pests when seen. Spray 1-2 seconds contacting insects directly. Insects contacted by spray will be killed.

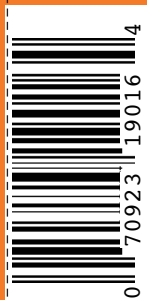
OUTDOORS: Remove all exposed food and cooking utensils. Cover all food handling surfaces or wash thoroughly after treatment and before use. Do not use on edible crops. Application is prohibited directly into sewer drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

Do not water the treated area to the point of runoff. Do not make applications during rain.

All outdoor application must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

1. Treatment to soil or vegetation around structures;
2. Applications to lawns, turf, and other vegetation;
3. Applications to building foundations, up to a maximum height of 3 feet.

Other than applications to building foundations, all outdoor applications to impervious surfaces such as sidewalks, driveways, patios, porches and structural surfaces (such as windows, doors and eaves) are limited to spot and crack-and-crevice applications, only.
