Always read label directions and precautions prior to use.
Shake well before use and periodically during use. Outdoor use only.

Sprayer Directions: Attach the bottle nozzle to a garden hose. Make sure the nozzle is in the OFF position, and turn on the water spigot to fully open. Extend hose to the farthest area to be treated. Hold the bottle upright and point nozzle toward the treatment site (not the ground). Bend the small plastic safety tab with your thumb and turn to "ON". Begin spraying, working back towards the spigot. The bottle will empty after 10-12 minutes of spraying. To stop spraying, turn to "OFF" position. Turn the water off. To relieve pressure before disconnecting nozzle from the hose, turn dial to "WATER" until the water stops. Then turn back to "OFF" position and disconnect from hose.

Treatment Directions: Mosquitoes and ticks tend to especially harbor and breed in areas of dense vegetation, and other areas where sunlight doesn't penetrate, such as under porches and decks. Spray to insure treatment reaches deep into heavy vegetation, versus just spraying the top. Grass should be no more than 3" high when treating for ticks. Apply at dusk to maximize treatment effects and minimize any potential for burning delicate plants. Apply at a rate of 500-600 sq ft per minute for mosquitoes and deer ticks. For larger tick species, such as Lone Star ticks, apply at a rate of 200-300 sq ft per minute. Reapply every two weeks, or as needed.

Precautions

- We recommend good safety practices when using any insecticide, such as avoiding contact with eyes and skin and avoiding directly breathing spray mist. If product gets in eyes, flush with water for at least 15 minutes. If on skin, wash with soap and water. If more than an incidental amount is swallowed, seek medical attention. Give one glass of water and do not induce vomiting. If in eyes, remove contacts and flush with water for 15 minutes. Seek medical attention for any persistent irritation. If seeking medical treatment, have this label with you.
- We recommend waiting until the spray is dry before allowing children or pets back into the treated area.
- Do not apply to food or plants grown for food. If the spray contacts a food surface like an outdoor dining table, wash with water and dish soap before using for food.
- Keep out of lakes, streams and ponds.
- We've tested the product on various types of plants without causing any burning or browning, but test treat a small area first to be certain if you're concerned about plant sensitivity, apply at dusk and be careful not to over-apply.

Storage & Disposal: Store in a cool, dry area out of reach of children and upright in the original, closed container. Don't reuse the container. Dispose of in trash or offer for recycling if available.
