USE ACCORDING TO LABEL INSTRUCTIONS.

For Indoor/Outdoor Applications:

Using a trigger sprayer, this ready-to-use formula may be sprayed into the air, on water-safe fabrics, carpet and hard surfaces. Thoroughly apply **United 249** to all visible insects to ensure a rapid kill. Make sure all insects receive a thorough coating of **United 249**. Resilient insects may require additional treatments. If unsure of surface compatibility, test in an inconspicuous area before use.

For Controlling Fruit Flies:

Spray **United 249** into and around the entire interior surface of drain, making contact with as many fruit flies as possible. Treat at regular intervals to prevent further infestation.

NOTE: Do not spray near open flame or sparks.
