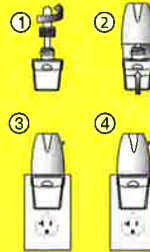

### INSTRUCTIONS FOR USE

1. Unscrew cap from fragrance bottle.
2. Insert fragrance bottle into warmer by pushing bottle up into device from below until click can be heard.
3. Plug warmer UPRIGHT into outlet. Rotate plug, if necessary. To rotate the plug, hold the front of the unit upright in one hand, grasp both metal plug blades in the other hand and rotate these blades about the center of the plug to which the blades are mounted. To prevent leakage, DO NOT plug in sideways or upside down.
4. To adjust fragrance intensity, push up or down on the button on side of warmer unit. (Up position=max. setting.)



**USER MAINTENANCE:** Fragrance oils may collect on warmer unit over time. To clean warmer unit, remove from electrical outlet and wipe with dry cloth. Replace fragrance bottle when empty, by gently pulling bottle down from unit. DO NOT immerse in water.

**MOVING AND STORAGE:** Remove warmer with refill from wall outlet. Remove refill from warmer and screw cap onto fragrance bottle. Store warmer and refill in a dry location. KEEP OUT OF REACH OF CHILDREN
