PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

Avoid contact with eyes and skin. Causes eye and skin irritation. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

FIRST AID

DIRECTIONS FOR USE

Read the entire label and SHAKE WELL BEFORE USE.

Use as a rodent repellent and chewing deterrent in cars, boats, RVs/Campers, trucks, cabins, barns, storage buildings, warehouses, offices, machinery, and homes. Spray targeted areas, such as under cabinets, in basements or crawl spaces, around the exterior of structures or vehicles, or bottom of fencelines, garden areas, trash containers, attics — or anywhere small rodents may be trailing or nesting liberally until it becomes damp. Treatment should be repeated after the odor diminishes. Repeat as necessary.

USE RESTRICTIONS: For use only in Non-Food areas. Do not treat surfaces likely to be contacted by food. Do not treat toys and stuffed animals with product. Product contains water and may damage or decolorize paper, fabric or some delicate surfaces or finishes. To avoid possible damage to furniture, test in an inconspicuous area before application. Not for use on pets or humans. Do not apply this product around electrical equipment due to the possibility of shock hazard.

NOTE: If you have a severe infestation we recommend using humane rat or mouse traps or other pest control methods.
