## PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS & DOMESTIC ANIMALS -CAUTION: Harmful if absorbed through the skin. Avoid contact with skin, eves or clothing. Prolonged or frequently repeated skin contact may cause allernic reaction in some individuals Wash thoroughly with soap and water after handling.

## FIRST AID:

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF IN EYES: Hold eve open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye, Call a poison control center or doctor for treatment advice

OUTDOOR USE: Use outdoors to prevent cats and kittens from disturbing flowerbeds, areas of lawn, trees, shrubbery, fences, patio furniture, and garbage cans/bags, NOTE: This product is not likely to break the established urination patterns of cats unless it is used as a training aid. Pretreatment Directions: Stray animals are frequently attracted to areas where pets have soiled with feces or urine. To discourage reneat visits, remove. any droppings and clean with water. Application Directions: Lightly spray surrounding soil or apply to a piece of cloth and affix near area to be protected every day. Retreatment Directions: Repeat daily, or as necessary, until undesirable habit is broken. Use Restrictions: Do not apply directly to foliage of shrubs or to ornamental, soft-bodied plants. Do not apply to food or feed crons

STORAGE AND DISPOSAL: Do Not Princture or Incinerate! STORAGE: Store only in a cool, dry place inaccessible to children and pets, away from heat or open flame.
